Recommendation: Staff recommends the Board appoint Dr. William Wainwright as the Interim Chancellor of Delgado Community College with an annualized additional duty compensation of \$26,372 (\$1,014.31 per pay period), effective September 13, 2018 through December 31, 2019. Additionally, staff recommends the system president be given the authority to provisionally appoint an acting chancellor of Northshore Technical Community College pending board ratification.

Background: The recent appointment of Ms. Joan Davis to the LCTCS Board office as the Sr. Vice President of Administration and Policy necessitates that her role as chancellor at Delgado Community College be filled with an experienced college leader on an interim basis to provide continued leadership for the largest LCTCS institution. Dr. William Wainwright, as chancellor of Northshore Technical Community College with over twenty years of technical and community college experience, brings a wealth of education and workforce experience and knowledge to meet this need. However, Dr. Wainwright's appointment as the chancellor of Delgado also necessitates the appointment of an acting chancellor to Northshore Technical Community College to provide continued leadership to the college. Given this, staff is recommending that the system president be given the authority to provisionally appoint an acting chancellor to Northshore Technical Community College for final ratification by the board at a later time.

Fiscal Impact: Minimal.

Benefits to System: These appointments will allow for the operational leadership of Delgado Community College and Northshore Technical Community College.
