A. CALL TO ORDER

The Louisiana Community and Technical College System Board of Supervisors met in Regular Session, March 12, 2008 at Baton Rouge Community College, Baton Rouge, Louisiana. Board Chair Brett Mellington called the meeting to order at 9:07 a.m.

B. PLEDGE OF ALLEGIANCE

Chair Mellington requested a few moments of silence in recognition of the faculty, staff and students of the Louisiana Technical College, Baton Rouge Campus. The assembly rose for recitation of the Pledge of Allegiance.

C. SWEARING IN OF NEWLY APPOINTED BOARD MEMBERS: LEON GIORGIO AND STEPHEN TOUPS

Mr. Leo Hamilton, General Counsel, Louisiana Community and Technical College System (LCTCS), conducted the swearing in of newly appointed board member, Mr. Leon L. Giorgio, Jr.

Mr. Giorgio stated that he is from New Orleans and serves as President and Chief Executive Officer of Select Properties. He noted that he has been involved in education at Delgado Community College for approximately ten years and is interested in workforce development and is an advocate of community and technical colleges. He added that he feels ". . . privileged to be honored to be here and I thank Dr. Johnson, (Chancellor, Delgado Community College), who has inspired me and motivated me . . ."

Chair Mellington welcomed Mr. Giorgio to the Board.

Mr. Toups was unable to attend the meeting due to a scheduling conflict.

E. APPROVAL OF FEBRUARY 13, 2008 AGENDA

On motion of Supervisor Johnson, seconded by Supervisor Carter, the Board voted to approve the March 12, 2008 agenda as presented.

F. APPROVAL OF MINUTES OF DECEMBER 12, 2007 FULL BOARD MEETING

On motion of Supervisor Franklin, seconded by Supervisor St. Blanc, the Board voted to approve the minutes of the December 12, 2007 Full Board meeting as presented. The motion carried.

G. REPORTS

1. Chair of the Board Report

Chair Mellington presented the Chair of the Board Report. The following topics were discussed:

- Attended Region 4 workshop in Lafayette. The workshop was well attended and provided an opportunity to speak with key stakeholders. Comments received from community sources have been very positive and appreciative of the effort. Thanked Board members for participation in workshops held in their respective areas. Dr. May stated that the next workshop will be held in Monroe. He expressed his appreciation to the Board for their participation. Supervisor Carter commented that the workshop held in Region 9 was excellent with great attendance and people are very interested.
- LCTCS Conference Day is scheduled for April 3-4, 2008. The conference presents an opportunity to interact with faculty and staff members attending the conference. Chair Mellington encouraged all board members to attend the conference and to notify Bonni Blouin if they plan to attend. Dr. May added that the date of the conference had been changed from August to April at the request of the chancellors and the length of the conference has been downsized to 1 ½ days. He noted that

Leah Goss, Director of System Advancement, is coordinating the event this year. He encouraged Board members to attend and noted that Governor Jindal has been invited to attend the conference to share his vision at it relates to the LCTCS.

2. President's Report

Dr. Joe May presented the President's Report. The following topics were discussed:

- Dr. May, on behalf of the Board of Supervisors, recognized Dr. Alex Johnson, Chancellor, Delgado Community College (DCC), for his contributions to the LCTCS. Dr. Johnson has accepted a position as President of Community College of Allegheny County in Pittsburgh. Dr. May expressed his appreciation to Dr. Johnson for his service and for his leadership to DCC.
 - Dr. Johnson acknowledged the staff at DCC and asked that they stand to be recognized. He extended his well wishes to the Board and recognized the LCTCS chancellors and regional directors. He stated that, ". . . as I leave this state, I will leave behind individuals that I truly love and care about and it is my hope to return on a regular basis to see you all. God bless you and thank you for having me."
- Mrs. Norene Smith, Regional Director, Region 8, shared information on a recent Council of Occupational Education (COE) visit. She stated that the COE team visited the Delta Ouachita campus on March 3rd and spent a week visiting the campuses in Region 8. She reported that no findings and no recommendations resulted from the visit. She added that there was a commendation on Standard 2 and the team was, ". . . elated at the enthusiasm among the student body at all the campuses and the quality of instruction and faculty in Region 8."
 - Dr. May commended Mrs. Smith and asked her to share the System's appreciation with her faculty and staff for their hard work in this endeavor.
- Mr. Travis Lavigne, Chancellor, Fletcher Technical Community College, introduced Ms. Jane Arnette, Executive Director, South Central Industrial Association. The South Central Industrial Association is a non-profit industrial group composed of 240+ businesses representing 40,000 employees in a tri-parish area: Lafourche, Terrebone and St. Mary. Ms. Arnette has created a plan called, "Work It Louisiana." Ms. Arnette stated that "Work It Louisiana" is an awareness campaign designed to educate students and parents on technical education, career paths and job opportunities. Ms. Arnette shared information on the campaign with the Board. She noted that the campaign is financed through HB 1.
- Dr. May reported that the LCTCS is moving forward with \$257.6 million worth of construction projects throughout the state. The Facilities Corporation is moving forward on the projects. Currently waiting on the cooperative endeavor agreements.
- Dr. Joe Ben Welch, Chancellor, River Parishes Community College (RPCC), shared the master plan for the construction project at RPCC. Angela Catrera, Director of Public Information, and Dr. Bill Martin, Executive Vice Chancellor, assisted in the presentation. Dr. Martin reviewed the historical background of the college from August 1998 to present. Dr. Welch discussed the proposed plans for the expansion of the college.

- Dr. May mentioned the publications/items that were placed at each Board member's station: "Transforming Louisiana's Workforce"; brochure on the Delgado Community College Chancellor Search; *Delgado Directions*; Legislative session agenda; copies of Senate Bill 1 and House Bill 1 from 2008 legislative session (document regarding Ethics Legislation for board review).
- Dr. May stated that the System is working very closely with the administration and legislature, the Secretary of Labor, Tim Barfield and Secretary of Economic Development, Stephen Moret to develop a comprehensive workforce development plan that will be aligned with Blueprint Louisiana, the LCTCS Advocacy Agenda, and the Louisiana Association of Business and Industry (LABI). The first indication of this plan was the Governor's announcement last week of "\$10 million dollars to jump start the LCTCS". Dr. May stated that this will be directed at improving the funding formula.

Dr. May stated that Dr. Jerry Pinsel has been working with System colleges to create a new system wide rank and promotion policy, including the initial placement of faculty into a rank system across the state. The draft policy was approved by the Board and Dr. Pinsel has been working with the colleges to create their own individual policies. All the colleges, with the exception of SOWELA Technical Community College, have submitted their policy for consideration by the Board. SOWELA is currently going through the SACS accreditation process and will submit their policy after this process has been completed.

4. Appointment of LCTCS Senior Vice President for Academic and Student Affairs

5. Appointment of Interim Chancellor at Delgado Community College

On motion of Supervisor Johnson, seconded by Supervisor Giorgio, the Board voted to ratify the appointment of Deborah R. Lea for the position of Interim Chancellor of Delgado Community College, at an annualized salary of \$150,000, effective March 16, 2008, and not to exceed June 30, 2008. The motion carried.

6. Appointment of Interim Vice Chancellor for Learning and Student Development at Delgado Community College

On motion of Supervisor Barham, seconded by Supervisor Johnson, the Board voted to approve the appointment of Mr. Harold Gaspard for the position of Interim Vice Chancellor for Learning and Student Development at Delgado Community College, at an annualized salary of \$115,000, effective March 15, 2008 and not to exceed June 30, 2008. The motion carried.

Supervisor Johnson expressed her appreciation to Dr. Alex Johnson for his commitment to Delgado Community College, his leadership to the New Orleans area and for his efforts following Hurricane Katrina.

Francisco, as Office Systems Program Instructor, immediately.

On motion of Supervisor Barham, seconded by Supervisor Johnson, the Board voted to immediately terminate the employment of Mr. Terryl M. Francisco, as Office Systems Program Instructor.
