FOR BOARD ACTION

Recommendation: Staff recommends that the Board approve of the program terminations listed below.

Program Terminations

- 1. Associate of Applied Science (AAS) in Surgical Technology (CIP 51.0909) - 4 STARS

Background: The administration at South Louisiana Community College requests the voluntary termination of the AAS in Surgical Technology. The Commission on Accreditation of Allied Health Education Program (CAAHEP) accredits the program. The last class of CAAHEP accredited students graduated May 14, 2015. There are zero students currently enrolled in the program. With zero impact to students a teach-out plan is not necessary, as all students have exited.

Fiscal Impact: There are no anticipated expenditures associated with this termination.

History of Prior Actions: There is a history of terminating programs due to low student enrollment.

Benefits to the System: The termination will allow SLCC to better meet student and workforce needs in other areas.

The last class that enrolled under CAAHEP accreditation graduated on May 14, 2015. The voluntary withdrawal of accreditation will go into effect as of this date.



Closure of the Surgical Technology program

REASON/JUSTIFICATION FOR THE PROPOSED CHANGE (Include support such as four-year university agreements, industry demand, advisory board information, etc.)

The resignation of the sole faculty member in August 2015 for Surgical Technology rendered this program inactive. Subsequently, no students are currently enrolled in the program and a teach out will not be necessary. In addition, according to the U.S. Bureau of Labor Statistics Occupational Outlook, Surgical Technology is expected to grow only by 22%.
