Recommendation: Staff recommends that the Board approve the conversion of the Howell Industries, Inc. Endowed First Generation Scholarship to the Howell Industries Endowed Scholarship – a Two-Year Student Workforce Scholarship.

Background: The Board of Regents will no longer fund matches for First-Generation Endowed Scholarships and is allowing these scholarships to be converted to Two-Year Student Workforce Scholarships with donor approval. SOWELA has received donor approval to convert this endowment.

History of Prior Actions: The Board of Supervisors has previously approved requests by colleges to modify or move endowments between colleges.

Fiscal Impact: There will be no direct fiscal impact from this conversion. In the future, however, the college may pursue additional matches through the Board of Regents that would not be possible without this conversion.

Benefits to System: This will help SOWELA to raise additional private funds and take steps towards reaching the asset goal laid out by Our Louisiana 2020.


As the designated campus officer for the Louisiana Board of Regents Support Fund, I request approval from the Louisiana Community & Technical College System (LCTCS) on behalf of SOWELA Technical Community College and its Foundation to convert a previously matched First Generation Endowed Scholarship to a Two-Year Student Workforce Scholarship. The request will convert the *Howell Industries, Inc. Endowed First Generation Scholarship* to the *Howell Industries Endowed Scholarship – a Two-Year Student Workforce Scholarship* and directed to students pursuing the Practical Nursing Technical Diploma.

The first semester Practical Nursing student curriculum consists of 19 credit hours. Due to this large course load and associated Nursing fees, students are charged an amount of tuition and fees that exceed the largest possible Pell grant that a student can receive. For this reason, scholarships such as this are needed to fill in the gap to assist our lowest income students with college expenses.

Mr. Guy Smith, General Manager of Howell Industries, approved of the conversion request on Sept. 25, 2017.

The SOWELA Foundation appreciates the past donations that established the *Howell Industries Endowed Scholarship* and benefitting first generation students at SOWELA Technical Community College. As a reminder, the scholarship received \$20,000 in match funds from the Louisiana Board of Regents Support Fund in 2016.


