E. APPROVAL OF MEETING MINUTES FROM SEPTEMBER 20, 2017

On motion by Supervisor Hitt, seconded by Supervisor Potts, the Board voted to approve the September 20, 2017, meeting minutes. The motion carried.

F. REPORTS

1. Chair of the Board Report

Chair Hardy provided the following report:

- ❖ Over the last 24 hours, the Board met to discuss the LCTCS strategic plan. During that time, ACCT Board Chair Emily Yim addressed the Board and Leadership team on the importance of mentorship in Board continuity. He thanked Ms. Yim for taking time out of her schedule to be in Baton Rouge all the way from Seattle, WA.
- Announced that Supervisor Woody Ogé was recently appointed to serve on the ACCT Communications and Education Committee. Additionally, Supervisor Hardy noted that he was appointed to serve on the ACCT Public Policy and Advocacy Committee. They are both honored to serve.
- ❖ ACCT's National Legislative Summit take place February 11 14, 2018, at the Washington, DC Washington Marriott Marquis. If you are interested in attending the Summit, please contact Sara Kleinpeter for registration information.
- ❖ The LCTCS Foundation launched its first annual fund campaign. Higher Louisiana is a campaign to advance the mission of community and technical colleges. Funds raised will support our statewide advocacy efforts. The fundraising goal is \$150,000; total raised to date is \$80,000. All gifts above the \$150,000 goal will be applied to the Curt Eysink Memorial Endowment for 2-year workforce scholarships.

Natalie Harder, Chancellor at South Louisiana Community College (SLCC) and a member of the LCTCS Foundation Board, reported that the Acadiana area hosted a small dinner in Lafayette, and as a result raised \$60,000 towards the Higher Louisiana Campaign.

Rick Bateman, Chancellor at Bossier Parish Community College (BPCC), reported that a gathering was held in Northwest Louisiana and was well attended. As a result, the BPCC Foundation, with a personal match by two board members, will donate \$10,000 to the Higher Louisiana Campaign.

 - Fletcher Technical Community College (FTCC) held a ribbon cutting announcement courtesy of a \$50K donation from Entergy to support the Certified Line Worker Training program. The Certified Line Worker Training Program is a partnership of the Louisiana Energy Workforce Consortium and LCTCS.

- ❖ Highlighted future ribbon cuttings and announcements:
 - Louisiana Delta Community College (LDCC) will have a press conference on November 9, 2017, announcing the award of the Small Business Development Center.
 - CLTCC will host grand opening of the Natchitoches campus on November 28, 2017.

Thanked all who have a part in advancing the colleges within the system, especially the Governor and LCTCS Leadership team for their work.

- ❖ Noted the new microphones and screens and thanked BRCC for the updated electronic equipment that is necessary for the Board meetings.
- ❖ As is protocol for open meetings, there is an opportunity for public comment at the end of the meeting. If you wish to make comments to the board, please fill out a comment card and turn it into Sara Kleinpeter, Board Coordinator.
 - 2. President's Report

Dr. Sullivan provided the following report:

- ❖ Noted that the Phase 2 of the ACT 360 projects has begun with the sale of bonds. He thanked Governor John Bel Edwards for his support and commitment to the LCTCS mission. He attended the announcements of the four projects Louisiana Delta Community College Tallulah and Monroe, Baton Rouge Community College, and Northshore Technical Community College Livingston Campuses
- ❖ Using personal privilege, Dr. Sullivan noted that employers have indicated that they have success when hiring those who have been farmers or have worked in a rural area. Knowing this, LCTCS sought out discussions with the Future Farmers of America (FFA) to work on an agreement to get FFA members from high school into LCTCS classrooms. He invited FFA representatives to address the Board. The representatives were:

Louisiana Executive Director, Eric Smith Brennan Uzee, a student at FTCC and graduate of Thibodeaux High School Jaci Cooper, a student at LSU and graduate of Ponchatoula High School

They were joined by Dr. Emily Campbell, LCTCS Interim Chief Enrollment Management Officer.

Together, they announced that LCTCS and FFA come to an agreement that LCTCS will offer a \$500 one time scholarship to every Louisiana FFA member who graduates from a Louisiana high school beginning the 17/18 school year and attending an LCTCS college the fall semester following high school graduation. Also offering at one time \$1,000 scholarship for each state champion beginning the fall 2018.

Mr. Smith is overwhelmingly excited about this partnership and the opportunity it presents for the students in FFA in Louisiana and for LCTCS. He is thrilled that he gets to "attend a competition today and announce this to the four winners."

Ms. Cooper stated, "I am extremely grateful to you for this opportunity for the students in FFA in Louisiana. Many graduate high school without the opportunity to attend college because of the cost. This will really benefit our FFA members. Thank you."

Mr. Uzee commented, "This is a really big benefit to our FFA members in Louisiana. And, it is a really good way to attract more FFA members to benefit from our legacy project with the money we can give them. So, thank you all for this contribution."

Supervisor St. Blanc noted that this agreement is special to him. He's a former FFA advisor and understands the importance of this organization and its impact on students. FFA is "one of the most important experiences in high school for students." He's thrilled to see this agreement take place.

❖ Informed the Board about a new program that SOWELA has implemented as it relates to Soft Skills Training during its curriculum. In an effort to develop a stronger work ethic in students, SOWELA had developed an industry leading strategy to make students aware of the need for academic and technical knowledge, along with a strong work ethic. Chancellor Aspinwall provided an overview to the Work Ethics Curriculum at SOWELA. A team was assembled nearly two years ago to develop a curriculum to teach work ethics along with classes. The team developed six work ethic skills to track. They are attendance, appearance, teamwork/cooperation, communication skills, following rules/civility, and organization/production. The program is a non-credit course that does not cost the student anything. At the end of the curriculum they get a course grade that shows up on the transcript. The course grades and work ethics grade is available to employers by requesting a transcript. The work ethics courses are built into the curriculum and have begun to take effect.

Supervisor Spohn asked Chancellor Aspinwall to follow up with the Board on the feedback/survey responses he receives from employers.

Supervisors Hardy, Carter, Potts, St. Blanc, and Ogé shared their thoughts that this is a vital program initiative for all students. The commend the work being done at SOWELA to increase the awareness that work ethics are just as important to the workforce as appropriate training in the class room.

❖ Announced that the first round of the Nunez Community College Chancellor Search has completed and three finalist will participate in an on campus interview on November 13, 2017. They are Tina Tinney, Ricky Thompkins, and Thomas Wright. A press release announcing the finalists will be issued following this meeting. He anticipates a recommendation on a Chancellor for Nunez Community College during the December Board meeting.

❖ In September as part of the LCTCS Annual Conference, LCTCS announced a partnership with Viacom/ CMT for an Empowering Education Tour with Louisiana Native, Courtney Cole. Director of Public Relations, Quintin Taylor noted that eight LCTCS colleges were chosen to participate. He introduced a video announcement by CMT artist and Louisiana native, Courtney Cole.

The schools participating in the free statewide tour are:

- o Bossier Parish Community College, Bossier City
- o Central Louisiana Technical Community College Rod Brady Campus, Jena

Mr. Taylor noted that the tour will take place over a two week period in the spring. The scheduled will be shared as soon as finalized. This is a great partnership with Viacom and could possibly be extended into future years.

Dr. Sullivan noted that the quality of the applications submitted by the LCTCS colleges was outstanding and

❖ Over the summer, LCTCS was approached by the Cristo Rey Organization to partner with them and have high school students in the office on a regular basis. The students are exposed to a professional work environment while completing their high school degree. He introduced Christo Rey student, Kelvin Rosas, to the Board.

McConathy Administration Building, the Lobby of the Health and Physical Education Complex the Billy Wayne Montgomery Health and Physical Education Lobby, and the Theatre Building stage the Stephen W. Slaughter Stage. The motion carried.

16. LCTCS Chancellor Contract Recommendations

On motion by Supervisor Spohn, seconded by Supervisor Price, the Board voted to authorize the President to amend college chancellor contracts as follows:

- All contracts for chancellors will continue to include allowances for housing and personal vehicle usage, or use of a state vehicle, and an allowance for civic organization expenses, as in the past.
- Contracts for chancellors in the first year of office will be extended to June 30, 2021 but otherwise remain unchanged with regards to the compensation terms initially approved by the Board.
- Contracts for all chancellors, except those in their first year of office, will include an annual deferred compensation benefit of \$10,000 effective January 1, 2018.
- The contract for the chancellor of Delgado Community College shall be extended to June 30, 2020.
- Due to additional duties from the realignment of former technical college campuses, contracts for the chancellors of South Louisiana Community College, Central Louisiana Technical Community College and Fletcher Technical Community College will provide for a 3% increase of base salary and be extended to June 30, 2020.
- Due to additional duties from the realignment of a former technical college campus, the contract for the chancellor of River Parishes Community College shall provide for a 3% percent increase of base salary and be extended to June 30, 2019.
- The contract for the chancellor of Bossier Parish Community College shall provide for a 5% increase to base salary and be extended to June 30, 2020.
- The contract for the chancellor of Northshore Technical Community College and SOWELA Technical Community College shall provide for a 7.3% increase to base salary and be extended to June 30, 2021.

• All above actions would be effective July 1, 2017. As per federal tax guidelines, the deferred compensation amount shall not be retroactive to the July 1, 2017 effective date.

The motion carried.

17. Chancellor Emeritus Status for Dr. Thomas R. Warner
