Recommendation: Staff recommends that the Board authorize the President and the Chancellor of South Louisiana Community College (SLCC) to negotiate and execute all documents necessary to acquire a parcel of property adjacent to the Lafayette Campus of SLCC. This transaction must be filed with the local Clerk of Court and the State Land Office.

LOUISIANA COMMUNITY & TECHNICAL COLLEGE SYSTEM

Background: The college proposes to acquire a 2.7 acre parcel of land located in the 100 block of Charolais Street, which is adjacent to the SLCC Lafayette Campus. The parcel will be purchased to limit the growth around the campus and provide additional space for future campus expansion in the event that should occur.

The board staff along with the SLCC staff will perform all due diligence prior to purchase of the property to ensure all requirements are fulfilled and to protect the interest of the LCTCS. Maps depicting the area to be purchased are on file in office of the LCTCS Vice President of Operations.

Fiscal Impact: The property has a listed price of \$180,000, but has not been appraised at this time.

Benefits to the System: The purchase of the property will limit the growth around the college and provide additional space for future campus expansion in the event that should occur.
