RE: Consulting Services Contracts between South Louisiana Community

College and Barbara R. Murray & Associates, LTD, Apprenticeship Services Group, LLC, Matsuda & Associates, and Ellis Consulting, LLC

FOR BOARD ACTION

Recommendation: Staff recommends that the Board approve consulting services contracts between South Louisiana Community College (SLCC) and Barbara R. Murray & Associates, LTD, Apprenticeship Services Group, LLC, Matsuda & Associates, and Ellis Consulting, LLC. These four contracts are all effective from September 21, 2018 to September 20, 2019 and are all subject to the approval of the Office of State Procurement, Professional Contracts.

Background: The former South Central Louisiana Technical College was awarded a competitively bid United States Department of Labor (USDOL) contract to launch multi-employer apprenticeship models in the transportation and logistics sector. SLCC acquired this USDOL contract through the realignment of the Young Memorial Campus with SLCC. The contract began on 9/21/16. The first year was the base year (9/21/16-9/20/17) with four (4) options to extend. The maximum amount if all options are exercised is \$7,910,127. The current year (2nd Option Year – 9/21/18-9/20/19) value is \$1,223,892.

In order to fulfill the requirements of the USDOL contract, SLCC seeks to enter into four separate consulting services contracts with the following entities:

- Barbara R. Murray & Associates, LTD to fulfill requirements of a subject matter expert (SME). The primary responsibility of the SME is to provide technical assistance to increase apprentices in the sector of ports, transportation, distribution, and logistics as well as expand and/or create occupations for apprenticeships.
- Apprenticeship Services Group, LLC to fulfill requirements of a project manager and marketing communications strategist. The Project Manager is responsible for day-to-day implementation of the project. As Marketing Communications Strategist, the contractor is responsible for developing, coordinating, executing, managing, and evaluating outreach communications strategies, plans and activities.

- Matsuda & Associates to fulfill requirements of a sales and marketing expert.
 The primary role of the Sales and Marketing Expert is to provide outreach and
 marketing to companies on the value of registered apprenticeships in the
 industry.
- Ellis Consulting, LLC to fulfill requirements of a senior analyst. The Senior Analyst provides technical assistance with developing the standards for the occupation to register the apprenticeship. Provides code justifications, on the job learning process and related training instructions. He also works with reporting information on the National Industry Reporting System and makes sure all procedures are approved within DOL Guidelines.

- Barbara R. Murray & Associates, LTD not to exceed \$210,000
- Apprenticeship Services Group, LLC not to exceed \$154,725
- Matsuda & Associates not to exceed \$68,000
- Ellis Consulting, LLC not to exceed \$60,000

Benefits to the System: The execution of these contracts will allow SLCC to fulfill requirements in the USDOL awarded contract that seeks to meet occupational and skill needs of high-growth industries in the transportation and logistics sector.
