On motion by Supervisor Mount, seconded by Supervisor Williams, the Board voted to approve the October 9, 2019, meeting minutes as presented. The motion carried.

#### F. REPORTS

1. Chair of the Board Report

Chair Toups provided the following report:

Presented former Supervisor, Representative Elect Vinney St. Blanc, with a plaque of appreciation, resolution of service and gift for his fourteen years as a member of the LCTCS Board of Supervisors. He will take office as State Representative on January 13, 2020.

The resolution reads as follows:

#### Vincent "Vinney" St. Blanc

Whereas, Vinney St. Blanc has served for 14 years as an LCTCS Board of Supervisor and provided outstanding service to the people of Louisiana through post-secondary educational and workforce development, and

Whereas, Vinney St. Blanc also served for more than 10 years as a vocational adult education teacher, vocational agriculture teacher, Future Farmers of America advisor, basketball and track coach of the Centerville High School earning the school its first track state title, and

Whereas, Vinney St. Blanc led the charge for equity and quality of life improvements as Mayor of Franklin, LA, and

Whereas, Vinney St. Blanc advocated on behalf of LCTCS to influence education policy and to ensure students had access to life changing academic and workforce training throughout Louisiana.

Therefore, Be It Resolved, that the Louisiana Community & Technical College System Board of Supervisors commends Vincent "Vinney" St. Blanc for his public service to not only Franklin, but the State of Louisiana as a whole; and

Be It Further Resolved, that upon his departure to serve as a Louisiana House of Representative for District 30, Vincent "Vinney" St. Blanc be recognized for his achievements and accomplishments as an LCTCS Board of Supervisor via this resolution on this 11th day of December 2019.

Mr. St. Blanc thanked the Board and System Office for their support. He is keenly aware of the work that LCTCS does and knows that it is a model representation of what is good in Louisiana. He's grateful for the opportunity to serve the State and for the support shown by all.

- Invited Central Louisiana Technical Community College (CLTCC) Chancellor Jimmy Sawtelle and Bill Fontenot, President & CEO of Cleco Corporate Holding, LLC to the table to make an announcement. Mr. Fontenot noted that Cleco is thrilled to make this million-dollar investment to CLTCC, explaining that the investment is also beneficial to the entire central Louisiana community and will aid in growing the workforce base in central Louisiana. Executive Vice Chancellor of Student Services, Enrollment Management & Foundation Relations, Heather Poole noted that these funds will be used to endow scholarships and professorships for CLTCC.
- Congratulated Supervisor Tim Hardy for his recent Chair's appointment to the Association of Community College Trustees (ACCT) Board for a year's term. Dr. Sullivan commended Sara Kleinpeter, Quintin Taylor, and Katie Waldrop for their work on Mr. Hardy's ACCT Campaign.
- Reminded Board members to attend the commencement ceremonies around the state over the next few weeks if they are able.
  - 2. President's Report
- Dr. Sullivan provided the following report:
  - Welcomed members of the current class of the Louisiana Certified Workforce Development program. He also recognized the alumni members of this program in the audience. He thanked Jennifer Daly Freeman for her work in planning and executing this program regularly.
  - Invited members to attend the LCTCS Advocacy meetings that will occur over the next few months across the state. He noted that the first Advocacy meeting was held at BRCC and was well attended by newly elected officials. The message of community colleges in Louisiana was well received.
  - Provided a federal legislative update. The Higher Education Reauthorization Act is moving through Congress. The current version of the Act includes a short-term Pell Initiative that provides for a certification in areas like NCCER. This is an initiative that will benefit our students in short-term certifications. A recent study was done and reveals that as a result of those short-term certifications, graduates are earning an increase of five to six thousand dollars annually.

The Futures Act was approved in the Senate that provides funding for HBCUs and minority serving institutions. Three colleges: Baton Rouge Community College (BRCC), South Louisiana Community College (SLCC), and Delgado Community

College (DCC) are identified as MSIs (minority serving institutions) and qualified for this funding.

- Fletcher Technical Community College (FTCC) Chancellor Kristine Strickland shared with the Board the news that an FTCC faculty member died in a car accident the week prior. Daphne LeRay was a math instructor who was loved by all – colleagues and students alike. She was an FTCC instructor for fifteen years and was named assistant department head of mathematics. A moment of silence was held to remember her.
- Provided the following college updates:
  - Nunez Community College (NCC) Chancellor Tina Tinney shared with the Board her journey to lead NCC in new directions that benefit both the students and faculty. She presented each Board member with a copy of the book *Tribe*.
  - SACSCOC will host their annual meeting in the next week. He noted the following colleges were reaffirmed in 2019: BRCC, River Parishes Community College (RPCC), SLCC, and SOWELA Technical Community College (SOWELA). Louisiana Delta Community College (LDCC), after much work, was placed in good standing with SACSCOC. Northshore Technical Community College (NTCC) received word that they are authorized for a candidacy visit from SACSCOC and noted that this has been an ongoing attempt for seven years.
  - Nursing capitation fund was reinstated across all nursing programs across the state of Louisiana. LCTCS Colleges were able to secure \$1.2 million of the \$2.5 million for nursing capitation, expanding the number of slots available in our system.
  - Congratulated SOWELA and SLCC for being named to the Aspen Institute's college excellence program's top 150 colleges in America, making them eligible for the million-dollar grand prize.
  - Congratulated NTCC and SOWELA on being recognized by the Aspen Institute for College Excellence in Equity Programs for eligibility to apply for the 2020 Excellence in Community College STEM Award.

# Dr. Sullivan presented the Board Development Item on the Agenda.

# G. BOARD DEVELOPMENT

1. Our Louisiana 2020 Goals #5 and #6: Business Partnership and Foundation Assets

LCTCS Chief Public Affairs Officer, Quintin Taylor, introduced Mr. Milton Graugnard, Chair of the Louisiana Construction Education Foundation (LCEF), and Mr. Chandler LeBeouf, Vice Chancellor of External Relations and Workforce Innovation at FTCC to the Board. He noted that the advancement teams across the System have exceeded goal #5 to Quadruple Business Partnership and are close to meeting goal #6 to Double Foundation Assets.

Mr. Graugnard noted that the LCEF Board is donating \$250,000 to the LCTCS Foundation to endow funds for scholarships in construction trades. He stated that LCEF is appreciative of the work of the community college system to train employees in the construction field.

Mr. LeBeouf discussed the importance of goals #5 and #6 working together to benefit each other. One of the ways that FTCC increased their foundation assets is by working to engage in business partnerships.

# Chairman Toups asked if there were any requests for public comment.

Ms. Kleinpeter noted that no requests for public comment were submitted.

Supervisor Price presented the Academic and Student Affairs Action Items for consideration by the Board.

4. For Board Action: Revisions to LCTCS Policy #2.019, Athletic Programs

# On motion by Supervisor Carter, seconded by Supervisor Mount, the Board voted to approve LCTCS Policy #2.019 titled "Athletic Programs." The motion carried.

Supervisor Spohn requests that staff review the issue of royalties for colleges with the use of college logos or mascots.

5. Student Referendum for South Louisiana Community College (SLCC)

On motion by Supervisor Mount, seconded by Supervisor Rushlow, the Board considered authorizing the Student Government Association (SGA) at South Louisiana Community College to conduct a referendum to assess a \$4.00 per credit hour student life fee each semester, subject to a twelve-hour cap of \$48.00. Following a lengthy discussion, Supervisor Mount withdrew her original motion.

SLCC Chancellor, Natalie Harder, addressed the Board and explained that SLCC's main and rural campuses suffer from lack of space for student organizations to meet on a regular basis. She noted that the proposed student led referendum request will result in a fee that will be dedicated to building a new student life center. The SLCC Student Government Association has engaged in presenting a referendum to build a new space on the main campus to host student activities. Supervisor Rushlow, as the President of SLCC's SGA, noted that she polled students across the campuses at SLCC. The visits made Ms. Rushlow aware of the lack of connection of the rural campus students to the main campus of SLCC. As a result of a survey of 400 students, they expressed the following needs: counseling/mental health, medical services, childcare, and more access to food. The services currently offered are not in a convenient place for access.

Dr. Sullivan noted that this board item is to approve a referendum for a fee, it does not approve the building of a new facility. Mr. Marin explained that there are structures in place for how student funds are used on campus.

Chancellor Harder ensured the Board that SLCC will be sure to follow the appropriate process for buildings.

On motion by Supervisor Mount, seconded by Supervisor Smith, the Board voted to authorize the Student Government Association at South Louisiana Community College to conduct a referendum to assess a \$4.00 per credit hour student life fee each semester, subject to a twelve hour cap of \$48.00, subject to the appropriate approval for facilities. The motion carried.

6. Institutional Accreditation Update for Select LCTCS Colleges

Supervisor Smith presented the Facilities Action Items for consideration by the Board.

8. Cooperative Endeavor Agreement between the Delgado Community College Foundation and the Louisiana Community and Technical College System

On motion by Supervisor Spears, seconded by Supervisor Price, the Board voted to authorize the President and the Chancellor of Delgado Community College to negotiate and execute a cooperative endeavor agreement between the Delgado Community College Foundation and the LCTCS, on behalf of the Delgado Community College, to construct an athletic building and to provide other baseball field improvements on the City Park Campus. The motion carried.

> 9. Acceptance of Property on Behalf of Central Louisiana Technical Community College from the LCTCS Foundation

On motion by Supervisor Williams, seconded by Supervisor Carter, the Board voted to authorize the President and Chancellor of Central Louisiana Technical Community College to negotiate and execute all documents necessary to accept the donation of property located at 803 6th Street, Alexandria, LA from Regions Bank, through the Louisiana Community and Technical College System Foundation. The transfer of this property must be recorded with the local Clerk of Courts and the State Land Office. The motion carried.

13. Board of Regents Statewide Matched Endowments – Construction Management Pathways

These funds will be equally distributed to our college foundations and require each college foundation to collectively match and bring the total private funds to \$440,000. The \$440,000 in private funds will be applied for an endowment by Board of Regents for an \$880,000 corpus. Such donations with statewide impact will take priority:
