D. APPROVAL OF MEETING AGENDA FOR FEBRUARY 12, 2020

On motion by Supervisor Spohn, seconded by Supervisor Salathe, the Board voted to approve the February 12, 2020, meeting agenda as presented. The motion carried.

E. APPROVAL OF MEETING MINUTES FROM DECEMBER 11, 2019

On motion by Supervisor Mount, seconded by Supervisor Spohn, the Board voted to approve the December 11, 2019, meeting minutes as presented. The motion carried.

F. REPORTS

1. Chair of the Board Report

Chair Toups provided the following report:

❖ Central Louisiana Technical Community College (CLTCC) Chancellor, Mr. Jimmy Sawtelle addressed the Board. Joining him were Mr. Eric Lord, Alexandria Market Executive for Regions Bank, and Dr. Heather Poole, CLTCC Executive Vice Chancellor of Student Services, Enrollment Management & Foundation Relations. Together, they highlighted the partnership with CLTCC and Regions Bank, and announced a land donation from Regions to CLTCC. Mr. Lord thanked the Board and CLTCC for their support of the people in the Alexandria community.

Chair Toups thanked Regions Bank for their support of LCTCS and CLTCC.

- ❖ River Parishes Community College (RPCC) Chancellor, Dr. Dale Doty, and St. Charles Parish United Way (SCPUW) Executive Director John Dias, addressed the Board. Along with them were VP and General Manager of Valero St. Charles and SCPUW Board Chairman, Mr. Jerry Stumbo, and SCPUW Campaign & Marketing Manager, Melissa Perrier. SCPUW recognized the charitable community that it serves, and the SCPUW Board commissioned the idea and plans to develop a campus in St. Charles Parish. This resulted in a \$3.1 million donation to purchase and outfit a training site in St. Charles Parish that will offer general education courses along with first year Process Technology and Instrumentation programs. Additionally, some advanced courses may be added if able. Mr. Dias thanked the Board for allowing SCPUW to work with RPCC on this need for the community. They anticipate courses will begin in August 2020.
- ❖ Student Board Members, Supervisor Samantha Rushlow and Supervisor Shanco Williams were both in Washington DC January 22nd -26th where they attended the Louisiana Council of Student Body Presidents Takes DC event. They were joined by other student body presidents from across the state where they met with congressional delegation members to talk about policy, focused on Higher Education. They were also treated to the flavor of 'Washington Mardi Gras' while they were there. We have a slide show of some photographs from their trip.

Additionally, they had the honor of attending the New Hampshire Presidential Primary in February.

Supervisors Rushlow and Williams shared with the Board a slideshow of photos and discussed their activities and meetings during both experiences. They are both thankful for the opportunity to learn about national political trends and how those trends impact Louisiana. They learned about responsible citizenship.

Chair Toups requested a pair of the Board of Regents socks that were worn in many of the photos of both trips.

Chair Toups shared with the audience that he was in DC for a Louisiana Chemical Association meeting and the LCA Board met with Senator Bill Cassidy. During the meeting, Senator Cassidy quoted Northshore Technical Community College Chancellor Will Wainwright on a discussion about workforce development. Chair Toups congratulated the entirety of the LCTCS Leadership team for their work to make sure that the Louisiana national leadership knows the importance of the work that LCTCS does.

- ❖ Announced that Supervisor Tim Hardy is in Washington, DC for the ACCT National Legislative Summit (NLS). The NLS is an annual community college advocacy event that shines a spotlight on the importance of community colleges to Congress and Administration. Supervisor Hardy is a member of the ACCT Board of Directors.
- ❖ Announced that Supervisor Willie Mount will serve as Chairman of the LCTCS Governance Committee. This committee will serve as needed with focus on the LCTCS Bylaws and governing topics.
- ❖ Announced that Rhoman Hardy was appointed to the LCTCS Board by Governor John Bel Edwards to fill the vacancy created when Mr. St. Blanc resigned. Mr. Hardy is an executive with Shell Corporation. He was unable to attend the meeting due to a schedule conflict, having been only recently appointed. He plans to attend the next meeting of the Board.

2. President's Report

Dr. Sullivan provided the following report:

- ❖ Held a moment of silence for Ali Ahmad, the Director of the Manufacturing Extension Partnership of Louisiana (MEPOL) who died unexpectedly in December. Mr. Ahmad was a talented asset to Louisiana and will be missed.
- ❖ Thanked outgoing LSU Chancellor King Alexander for his leadership role in Louisiana and for his work with transfer students. When Dr. Alexander arrived at LSU in 2013, there were roughly only 50 transfers from LCTCS

colleges to LSU. Most recently, there were more than 1,500 transfers from LCTCS colleges to LSU, representing a tremendous growth in the relationship between community colleges and four-year colleges in Louisiana.

- ❖ Invited Mr. Tommy Williams to discuss the LCTCS Advocacy Tour for 2020. Mr. Williams thanked the Board for their service to the Board and the System. The legislative turnout for the 2020 LCTCS Advocacy has been great, and we currently stand at 84 of the 144 legislators having attended a meeting. There is one remaining meeting, at Fletcher Technical Community College, and the goal of 60% legislative attendance will likely be met.
- ❖ Provided an update on federal policies as related to higher education and workforce. There is a movement at the federal level to focus on career and technical education along with workforce training, and reentry efforts for the incarcerated as well as Workforce Pell. The range of focus is large but will likely result in a reinvestment in the Carl D Perkins Fund.
- ❖ Dr. Sullivan handed out a report titled "Strong Wage Gains from Short Term Credentials" that was created as a result of research done in coordination with Old Dominion University. The report is embargoed at this time and will be presented at the Federal level by Senators Tim Kaine and Bill Cassidy.
- ❖ Dr. René Cintron informed the Board on the status of the Data Integration Project. There are more than forty tools/programs being used across all LCTCS colleges to collect and maintain data. The colleges met to discuss best practices and what would be best for the colleges in the future.
 - Dr. Cintron invited John Lefante from DXC Technology to discuss their partnership with LCTCS and its colleges. DXC remains excited to work with the colleges and LCTCS to best engage in data integration. Dr. Amy Cable, LCTCS Executive Director of Process Improvement, detailed the process for best determining the needs of data collection and recording and detailing the business processes of enrolling and graduating LCTCS students. There is a strong desire across the colleges for better and consistent data, reporting like things, integrating systems to provide a better human experience across the board.
- ❖ Invited the Board to attend the Phi Theta Kappa All State 2020 Celebration on March 20th in Baton Rouge at Juban's beginning at 11:00 am.
- ❖ Announced a \$1,000 construction scholarship during the Statewide Jumpstart meeting recently. This scholarship is made possible through the support of the Louisiana Construction Education Foundation (LCEF), Associated Builders & Contractors (ABC) Pelican Chapter, and the LCTCS Foundation.

- Provided the following college updates:
 - Congratulated all colleges for the increased enrollment that is occurring.
 - South Louisiana Community College will hold an announcement at 10:00 am on March 18th at their Health Science Bldg. This announcement will be huge and he encouraged all to attend if available.

Dr. Sullivan presented the Board Development Item on the Agenda.

G. BOARD DEVELOPMENT

1. Our Louisiana 2020 Goals #1 and #6 Update: Graduates and Foundation Assets

Dr. Cintron reviewed in detail the status of Goal #1: Double Graduates. The target is 40,000 students graduated at the end of the year. To date, we are just over 16,000 graduates and we are on target to meet the goal by June 30, 2020. The implementation of Degree Works has greatly increased the ability of colleges to help students recognize the best path to graduation. The Board of Regents has begun to recognize Industry Based Certificates (IBCs) as degree earning under the Career and Technical Certificate designation. A focus on pathways that align with industry allows graduates to go to work upon graduation. These things have helped to keep the system on track to achieve the goal.

LCTCS Chief Public Affairs Officer, Quintin Taylor updated the Board on the status Goal #6: Double Foundation Assets. He noted that donors to the College and LCTCS Foundations give because we produce their employees and supply a trained workforce for the State of Louisiana. The System is on track to attain Goal #6.

Dr. Sullivan noted that the staff is looking forward to the June meeting to give a preliminary wrap up to the Our Louisiana 2020 Goals.

Chair Toups asked if there were any requests for public comment.

Ms. Kleinpeter noted that no requests for public comment were submitted.

On motion by Supervisor Mount, seconded by Supervisor McConduit, the Board voted to approve the consolidation of personnel and programmatic offerings by Louisiana Delta Community College in Bastrop, La. to a single location at 6376 Airport Rd. and to authorize the System President and Chancellor to negotiate and execute all documents necessary for the disposal of the property located at 729 Kammell St. in Bastrop through sale, transfer or trade. The motion carried.

3. 5. Cooperative Endeavor Agreement between the Union Parish School Board and Louisiana Community and Technical College System, on Behalf of Louisiana Delta Community College

On motion by Supervisor Price, seconded by Supervisor Bradford, the Board voted to authorize the President and the Chancellor of the Louisiana Delta Community College to negotiate and execute a cooperative endeavor agreement with the Union Parish School Board for use of a property located at 300 Anthony Street, Farmerville, LA. The motion carried.

Supervisor Price withdrew the original motion and instead offered the following motion in replacement. The withdrawal of the original motion was seconded by Supervisor Bradford.

On motion by Supervisor Price, seconded by Supervisor Bradford, the Board voted to amend prior Board action and authorize the President and the Chancellor of the Louisiana Delta Community College to negotiate and execute either a donation, a lease or a cooperative endeavor agreement (CEA) with the Union Parish School Board for use of a property at located at 300 Anthony Street, Farmerville LA. The motion carried.

6. Escrow Agreement amendment between Jefferson Parish Economic Development and Port District (JEDCO), LCTCS Facilities Corporation and LCTCS Board of Supervisors
