Recommendation: Staff recommends that the Board approve a social services contract between Delgado Community College and The Cart Provider, LLC, effective July 1, 2020 through June 30, 2021. This contract is subject to the approval of the Office of State Procurement.

Background: Delgado Community College seeks to enter into a social services contract with The Cart Provider, LLC to provide captioning and interpreter services to hearing impaired students.

Fiscal Impact: The contract is for a maximum fee of \$200,000.

History of Prior Actions: The Board approved a similar contract between Delgado Community College and The Cart Provider, LLC at the January 2016, November 2018, and August 2019 meetings.

Benefits to the System: The contract will provide needed interpretive services to Delgado Community College hearing impaired students.
