FOR BOARD ACTION

Recommendation: Staff recommends the Board appoint Dr. Vincent June as interim chancellor of South Louisiana Community College, with an employment contract effective May 30, 2020 through November 29, 2020 with a compensation package consisting of an annual base salary of \$172,519, a housing allowance of \$20,000, a vehicle allowance of \$5,000 (or the use of a college vehicle) and a civic organization allowance of \$2,500.

Background: Dr. Natalie Harder recently announced her departure as chancellor of South Louisiana Community College effective May 29, 2020 to become the president of Coker University in North Carolina. Given this, there is a need to name an interim chancellor for continued leadership at the college while it undergoes a chancellor search.

Dr. June joined SLCC in 2016 and currently serves as the Vice Chancellor for Academic and Student Affairs. His higher education career spans 25 years, including 17 years as the chief student affairs-enrollment officer at three major institutions: Florida Gulf Coast University, Florida A&M University, and Georgia Perimeter College (now Georgia State University-Perimeter College). He was a 2014-2015 ACE Fellow with the American Council on Education, where he spent the fellowship year at Cuyahoga Community College - Cleveland, Ohio. Dr. June earned his BS in business and economics from Florida A&M University and received an MBA and Ph.D. in educational leadership and student affairs from Washington State University. His years of progressive work experience makes him qualified to serve as the interim chancellor of South Louisiana Community College.

Fiscal Impact: None, as funds are budgeted for the chancellor position.

Benefits to System: This appointment will allow for the continued operational leadership of South Louisiana Community College.
