Background: South Louisiana Community College (SLCC) is seeking approval to close the Helicopter Aviation program. The cost to sustain the program versus the number of students the program serves in unsustainable. Beginning in the fall of 2020, the program will no longer accept new students. All current students, eleven (11), will be provided with a curriculum plan and the opportunity to complete all degree requirements in the program. Anticipated teach-out completion is December 2021, pending the return to campus. The teach-out will need to be altered if Covid-19 prevents students from returning to campus in a timely fashion.

South Louisiana Community College (SLCC) is seeking approval to delete programs from the curriculum inventory that were used in the teach-out of the SCLTC -Young Memorial merger. All students have completed their teach-outs and the listed programs are now inactive. New students will be enrolled in the aligned SLCC program and CIP code.

Fiscal Impact: The administrative structure will not change. There are no anticipated expenditures associated with this addition.

History of Prior Actions: There is a history of revising and creating new programs to meet student and workforce needs.

Benefits to the System: These requests will allow SLCC to better meet student and workforce needs.
