**SUBJECT:** Appointment of Chancellor for Louisiana Delta Community College

### FOR BOARD ACTION

**Recommendation:** Staff recommends the Board appoint Dr. William Scott Rule as Chancellor of Louisiana Delta Community College, with an employment contract effective January 1, 2021 through June 30, 2024. Staff further recommends a fair and equitable chancellor package consisting of an annual base salary of \$190,000, a housing allowance of \$20,000, a vehicle allowance of \$5,000 (or the use of a college vehicle), a civic organization allowance of \$2,500 and an employer sponsored deferred compensation package of \$20,000.

**Background:** Louisiana Delta Community College undertook a comprehensive national search for a permanent chancellor for the college with the departure of Chancellor Dennis Epps. After following the LCTCS college chancellor search protocols that have been in place for years, Dr. William Scott Rule has been nominated as the candidate most qualified for the position.

Dr. Rule currently serves as president of West Georgia Technical College in Carrollton, Georgia. He began his career as a computer programmer at Kennesaw State University, where he also taught evening classes as well at North Metro Technical College. Then he moved to the Board of Regents of the University System of Georgia before returning to North Metro Technical College as full-time faculty member, database administrator, and Chief Information Officer. After a decade at North Metro Technical College, Dr. Rule served as Vice President for Academic Affairs at Appalachian Technical College before returning to North Metro Technical College, again, as Vice President for Economic Development. Dr. Rule also served six years as Vice President for Student Affairs at Chattahoochee prior to being named by the Technical College System of Georgia as its Assistant Commissioner for Data, Planning, and Research.

**Fiscal Impact:** None as funds are budgeted for the chancellor position.

**Benefits to System:** This appointment will allow for the continued operational leadership of Louisiana Delta Community College.
