**SUBJECT:** Appointment of Chancellor for South Louisiana Community College

## FOR BOARD ACTION

**Recommendation:** Staff recommends the Board appoint Dr. Vincent June as chancellor of South Louisiana Community College, with an employment contract effective December 9, 2020 through June 30, 2024. Staff further recommends a fair and equitable chancellor package consisting of an annual base salary of \$183,250, a housing allowance of \$20,000, a vehicle allowance of \$5,000 (or the use of a college vehicle), a civic organization allowance of \$2,500 and an employer sponsored deferred compensation package of \$15,000.

**Background:** South Louisiana Community College undertook a comprehensive national search for a permanent chancellor for the college with the departure of Dr. Natalie Harder. After following the LCTCS college chancellor search protocols that have been in place for years, Dr. Vincent June has been nominated as the candidate most qualified for the position.

Since May of 2020, Dr. Vincent June has served as the interim chancellor of South Louisiana Community College overseeing college operations including the development and implementation of a college-wide COVID-19 response and reopening plan while also executing strategic efforts to support summer and fall 2020 enrollment initiatives requiring an individual with tested college leadership skills. Prior to this, Dr. June's work experience included serving as the Vice Chancellor for Academic and Student Affairs at South Louisiana Community College, Vice President for Student Affairs and Enrollment Services at Georgia Perimeter College, Vice President for Student Affairs and Enrollment Services at Florida A&M University and Dean of Student Services for the Division of Student Affairs at Florida Gulf Coast University. Due to this extensive experience, Dr. June is best equipped to provide leadership for South Louisiana Community College.
