FOR BOARD REVIEW AND ADVISEMENT:

Recommendation: Staff recommends that the Board accept for review and advisement
the retirement of LCTCS Policy #2.001 ("Military Selective Service Act for
Admission") and LCTCS Policy #2.002 ("Selective Service & Immunization
Documentation).

Background: LCTCS Policy #2.001 was approved in 2001. LCTCS Policy #2.002 was
approved in 2002. In 2016, LCTCS Policy #1.004 was revised to encompass a
comprehensive General Admissions Policy Statement. The revision of LCTCS Policy
#1.004 rendered both LCTCS Policy #2.001 and #2.002 redundant. The Chief Student
Affairs Officers (CSAO) Group has approved of these policy retirements.

History of Prior Actions: LCTCS Policy #2.001 was approved in 2001. LCTCS
Policy #2.002 was approved in 2002. Neither has been revised since.

Fiscal Impact: N/A

Benefits to the System: Having a single Policy (LCTCS #1.004) that encompasses the
admissions framework for the system will provide a streamlined policy landscape.
