### FOR BOARD ACTION

**Recommendation:** Staff recommends that the Board approve River Parishes Community College naming opportunities at its new St. Charles campus.

Background: River Parishes Community College partnered with the United Way of St. Charles to create a one of a kind community partnership that provides credit, noncredit, and adult education programs in St. Charles Parish. The two parties have agreed to a cooperative endeavor agreement that calls for the United Way of St. Charles to provide a campus location in Boutte, LA for RPCC to teach classes. Both parties have agreed to refer to this location as "River Parishes Community College - United Way of St. Charles Campus."

Fiscal Impact: River Parishes Community College agrees to pay a monthly operating cost of \$500 (to be paid by RPCC to United Way). If the funds are not spent for maintenance and repair costs related to the Facility, by the end of each year (December 31), 50% of the amount not spent will be refunded to RPCC.
