

FOR BOARD ACTION

Recommendation: Staff recommends that the contracts for Chancellor Randall Esters, of Louisiana Delta Community College, and Chancellor Vincent June, of South Louisiana Community College, be extended by six months to align them timewise with the other chancellors of the LCTCS. This action will allow the LCTCS Board of Supervisor the ability to review all chancellor contracts at the same time and provide the needed notice of 365 days prior to a recommendation of contract continuation.

Background: At the December 2021 board meeting, all chancellor contracts were updated to include contract language whereby the LCTCS Board of Supervisors would indicate its intent toward a new employment agreement within 365 days of the termination date of a chancellor's contract.

History of Prior Actions: The Board last acted on chancellor contracts at the December 2021 meeting.

Benefits to System: The extension allow all chancellor contracts to end at the same time, at the end of a calendar year. The LCTCS Board of Supervisors usually reviews and acts on chancellor contracts in the month of December, and therefore this board action would provide for consistency for all chancellors.
