SUBJECT: Acquisition of Property for Louisiana Delta Community College Winnsboro Campus

FOR BOARD ACTION

Recommendation: Staff recommends that the Board authorize the System President and the Chancellor of Louisiana Delta Community College (LDCC) to negotiate and execute all documents necessary for the purchase of two (2) parcels of land adjacent to the Winnsboro Campus. Recording of the property with the Division of Administration, State Land Office, is required and a copy of the property's legal description is available in the office of the Vice President of Operations. A depiction of the location of the property is attached.

Background: Louisiana Delta Community College Winnsboro Campus has undergone a major transformation in its site development over the last eight years with the acquisition of a facility in 2014 through capital outlay funding which was renovated through Act 360 funding. In 2022, the college received an appropriation through capital outlay to fund an expansion of the Winnsboro Campus. The expansion of the campus is currently being designed and construction should begin fall 2023.

LDCC proposes to use these two properties, totaling 8.3 acres, for additional parking for the expanded campus and to provide additional workforce training space for future high demand high wage programs. The acquisition of this additional property will ensure that the campus does not become landlocked between the existing businesses, which have also expressed an interest in expanding onto this same property, and will allow the college to control the growth around the college.

Fiscal Impact: The two parcels have a combined appraised value of \$154,000 and the college propose to fund the acquisition of the property from its operating budget.

History of Prior Actions: N/A

Benefits to the System: The purchase of this property will allow additional space for the college to expand, and it will allow the college to control the growth near the campus.
