# MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF LCTCS FACILITIES CORPORATION

March 10, 2010 1:30 p.m.

A duly called meeting of the Board of Directors of LCTCS Facilities Corporation (the "Corporation") was held at LCTCS and by conference call on March 10, 2010. Those directors of the Corporation present include: Stevie Smith, Chair; Jimmy Dimos, Secretary (by phone); Lambert Boissiere, Treasurer; Billy Montgomery (by phone) and Joe May, Ex-Officio Member. Other participants include Jan Jackson, Bill Obier, Robert Atkinson (by phone), Leo Hamilton, Bob Bowsher, Curt Soderberg, Brian LaFleur, Lane Sisung, Liza Sherman, and Michele Nardini.

## 1. Approval of minutes from January 13, 2010 meeting

On the motion of Director Montgomery, seconded by Secretary Dimos, the minutes from the LCTCS Facilities Corporation meeting held on January 13, 2010 were unanimously approved.

## 2. Program Management Presentations

Mr. Brian LaFleur presented information on the following three project delivery methods:

- Design Bid Build
- Traditional Design Build
- Design Build with Bridging

Mr. LaFleur explained how each method operates and pointed out pros and cons of each method. The group discussed how the Phase I, Act 391 projects fit into the different categories. The LCTCS Facilities Corporation directors agreed that they wish to be involved in the review and approval of the shortlist of contractors that submit responses to the design build RFQ.

#### 3. Updates on Campuses with Outstanding Issues Delaying Implementation

Mr. Lane Sisung discussed potential delays in the acquisition of the Gay Property in Plaquemine and said the delays might remove that property from consideration as the next site of the Northwest Campus. He said there was an alternate site being discussed located near Plaquemine High School. Mr. Sisung stated the alternate site was a piece of land that may be donated by Dow Chemical Co.

The group discussed the inability to reach an agreement with Facility Planning and Control on an MOU for the joint effort of renovation and construction of the Stewart Administration building at Nunez Community College. After discussion of different scenarios

that might resolve the issue, the group decided additional meetings between the various parties would be necessary.

# 4. Phase I Campus Project Updates

Mr. Brian LaFleur updated the group on the status of programming at the Huey P. Long, L. E. Fletcher and Northwest projects. He stated Mr. Rich Griswold from FP&C expressed concern about the per square foot cost and metal building structure proposed for those facilities. Mr. Bill Obier led a discussion on the clear span metal structure that was suggested for construction and provided photographs and sketches depicting buildings that were constructed with these materials.

Mr. LaFleur reviewed the Control Report provided by CSRS and fielded several clarifying questions.

#### 5. RFQ for Design/Build Projects

On the motion of Treasurer Boissiere, seconded by Secretary Dimos, the Board unanimously approved the RFQ for design builder that was recommended by the Advisory Committee for the Central Louisiana Technical College, Huey P. Long Campus in Winnfield Louisiana, and approved the release of the RFQ for advertisement in the *The Advocate* and in local publications in the area of the project, as well as notification of the release of the RFQ to those who expressed interest in the project.

# 6. Administrative and Accounting Matters

Mr. Sisung reported that the following expenses were paid since the last meeting:

1) Bryant Hammett & Associates LLC in the amount of \$1,376.26; and, 2) Primeaux & Associates in the amount of \$2,000.00. He noted that both payments were for surveying services at the Shelby M. Jackson and Gulf Area Campuses, respectively, necessitated by the Ground and Facilities leases.

On the motion of Secretary Dimos, seconded by Director Montgomery, the Board unanimously approved the attached Resolution authorizing Chair Smith or Secretary Dimos to sign the necessary documents that would transfer title of those properties described in "Exhibit A" of the Resolution to the State of Louisiana, and to amend the Ground Lease, the Facilities Lease, and the Mortgage to include those properties.

#### 7. Scheduling for next meeting

Chair Smith asked that Wednesday, April 14 and April 28, 2010, be held as tentative dates for the next meeting. Ms. Jackson said she would notify everyone when a date was selected.

The meeting adjourned at 3:10 p.m.

# RESOLUTIONS OF THE BOARD OF DIRECTORS OF LCTCS FACILITIES CORPORATION

WHEREAS, by unanimous consent of the Board of Directors of LCTCS Facilities Corporation (the "Corporation") dated October 1, 2009, the Board of Directors authorized the Corporation to enter into, execute and deliver (i) a Ground Lease Agreement (the "Ground Lease"), by and between the Board of Supervisors of the Louisiana Community and Technical College System (the "Board"), as lessor, and the Corporation, as lessee, pursuant to which the Board is leasing to the Corporation certain tracts of land with the improvements, if any, thereon, on which will be constructed new buildings and renovations on fourteen (14) campuses of the Louisiana Community and Technical College System (the "LCTCS"), (ii) an Agreement to Lease With Option to Purchase (the "Facilities Lease"), by and between the Corporation, as lessor, and the Board, as lessee, pursuant to which the Corporation is leasing back to the Board those buildings to be designed, constructed and renovated by the Corporation on the lands leased under the Ground Lease, including furnishings and software (the "Facilities"), the cost of which Facilities will be financed by the issuance of the \$66,000.000.00 Louisiana Local Government Environmental Facilities and Community Development Authority Revenue Bonds (LCTCS Facilities Corporation Project) Series 2009A and Series 2009B (the "Bonds"), and (iii) an Act of Leasehold Mortgage, Assignment of Leases and Security Agreement (the "Mortgage") pursuant to which the Corporation encumbered certain of its property in connection with the issuance of the Bonds; and

WHEREAS, in accordance with that Unanimous Consent of the Board of Directors of the Corporation, the Corporation did enter into the Ground Lease, Facilities Lease and Mortgage; and

WHEREAS, the Corporation has acquired tracts of land located in Terrebonne Parish, Louisiana and in St. Helena Parish, Louisiana, and the Corporation has surveyed tracts of land located in St. Mary Parish, Louisiana, Concordia Parish, Louisiana, and Vermilion Parish, Louisiana owned by the State of Louisiana for the use and benefit of the LCTCS; the two (2) tracts of land acquired by the Corporation and the three (3) tracts of land surveyed by the Corporation and owned by the State of Louisiana for the use and benefit of the LCTCS are described on "Exhibit A" attached hereto; and

WHEREAS, in furtherance of the purpose of Act 391 of the 2007 Regular Session of the Louisiana legislature, the Corporation intends to construct Facilities on the tracts of land described on "Exhibit "A" (the "Facilities"); and

WHEREAS, to facilitate the construction of the Facilities and to facilitate the financing of the Facilities, through the issuance of the Bonds, it is necessary that the Corporation transfer title to the properties located in Terrebonne Parish, Louisiana and in St. Helena Parish, Louisiana and described on "Exhibit A" hereto to the State of Louisiana for the use and benefit of the LCTCS and that the Corporation amend the Ground Lease, the Facilities Lease, and the Mortgage to include all of the properties described on "Exhibit A", together with the Facilities.

NOW. THEREFORE, BE IT RESOLVED that the Corporation is authorized to enter into, execute and deliver: (i) an Act of Transfer transferring title to the properties described on "Exhibit A" hereto and located in Terrebonne Parish, Louisiana and St. Helena Parish, Louisiana to the State of Louisiana, for the use and benefit of the LCTCS; (ii) an Amendment No. 1 to Ground Lease Agreement, by and between the Board, as lessor, and the Corporation, as lessee, pursuant to which all of the properties described on "Exhibit A" will be added to those properties currently subject to the Ground Lease; (iii) an Amendment No. 1 to Agreement to Lease With Option to Purchase, by and between the Corporation, as lessor, and the Board, as lessee, pursuant to which the Facilities located and to be located on those properties described on "Exhibit A" will be added to those properties currently covered by the Facilities Lease; and (iv) an Amendment No. 1 to Act of Leasehold Mortgage, Assignment of Leases and Security Agreement pursuant to which those properties described on "Exhibit A" will be added to those properties which are subject to the terms and conditions of the Mortgage; all of which agreements are hereby approved substantially in the forms presented to the Board of Directors of the Corporation and filed in the official minutes of the Corporation, with such changes as shall be approved by counsel to the Corporation.

**BE IT FURTHER RESOLVED** that all actions taken or performed by the Corporation, or any of its officers, employees, attorneys, or agents prior to the date hereof, in connection with the Bonds and the transactions contemplated hereby be, and they hereby are, approved, ratified and confirmed in all respects.

**BE IT FURTHER RESOLVED** that the President, Stephen C. Smith, or the Secretary, Jimmy N. Dimos, of the Corporation be, and they hereby are, authorized to execute and deliver any and all instruments, perform any and all acts, approve any and all matters, and do any and all things deemed by them necessary or desirable in order to carry out the purpose of the foregoing Resolutions.
