MINUTES OF THE MEETING OF THE BOARD OF DIRECTORS OF LCTCS FACILITIES CORPORATION

May 3, 2012 10:00 a.m.

A duly called meeting of the Board of Directors of LCTCS Facilities Corporation (the "Corporation") was held at SOWELA Technical Community College and by conference call on May 3, 2012. Those directors of the Corporation present included: Stevie Smith, Chair/President; Lambert Boissiere, Secretary/Treasurer, Billy Montgomery and Judge Gene Thibodeaux. Other participants included Jan Jackson, Bill Obier, Brian LaFleur, John Mayeaux, Liza Sherman, David Darbonne and Michele Nardini.

Approval of Minutes from April 3, 2012 Meeting:

On the motion of Director Thibodeaux, seconded by Secretary/Treasurer Boissiere, the Board approved the minutes of the April 3, 2012 meeting, as presented.

Board Review and Approval of Furniture, Fixtures & Equipment (FF&E) Contract for SOWELA Technical Community College, Arts & Sciences Classroom Building, Lake Charles:

Brian LaFleur requested that the board approve a contract for Champeaux Evans Hotard, APAC, the current project architect, for the design and procurement of FF&E for SOWELA Technical Community College, Arts & Sciences Classroom Building. Mr. LaFleur reported the FF&E budget was \$650,000 and the bidding process would take approximately two months.

On the motion of Director Thibodeaux, seconded by Secretary/Treasurer Boissiere, the Board approved awarding a contract to Champeaux Evans Hotard, APAC for design and procurement of FF&E for SOWELA Technical Community College, Arts & Sciences Classroom Building.

Board Review and Approval of Furniture, Fixtures & Equipment (FF&E) Contract for Northwest Louisiana Technical College, Northwest Campus, Minden:

Brian LaFleur requested that the board approve a contract for Yeager, Watson & Associates, Inc., the current project architect, for the design and procurement of FF&E for the Northwest Louisiana Technical College, Northwest Campus in Minden. Mr. LaFleur reported the FF&E budget was approximately \$400,000.

On the motion of Director Montgomery, seconded by Secretary/Treasurer Boissiere, the Board approved awarding a contract to Yeager, Watson & Associates, Inc. for the design and

procurement of FF&E for the Northwest Louisiana Technical College, Northwest Campus in Minden.

Board Review and Approval of Change Order #7 for Central Louisiana Technical College, Ferriday Campus Project:

Mr. Brian LaFleur described the items in Change Order #7, totaling \$57,967.29, for Central Louisiana Technical College, Ferriday Campus Project, as listed below. Mr. LaFleur reported the campus was substantially complete, the college had moved in to the building and Change Order #7 would be the final change order for the project, with approximately \$40,000 remaining in the contingency fund.

Mr. Brian LaFleur described the items listed in Change Order #2, totaling \$114,175.11, for Northshore Technical Community College, Florida Parishes Campus Project, as listed on the following page. Mr. LaFleur reported the change order would extend the substantial completion

date to June 18, 2012 and the remaining contingency balance would be approximately \$115,000 after Change Order #2.

Mr. LaFleur explained the sewer line portion of the change order resulted from an error in the original survey, necessitating the relocation of the sewer line.

Brian LaFleur reviewed Change Order #1 for FF&E, which would substitute Lincoln Manufacturing Welding Booths for GMI Welding Booth at the Northshore Technical Community College, Florida Parishes Campus, in the amount of \$28,470.40. Mr. LaFleur reported the remaining contingency balance for the project would be about \$93,000 after Change Order #1.

On the motion of Secretary/Treasurer Boissiere, seconded by Director Thibodeaux, the Board approved Change Order #1 for FF&E at the Northshore Technical Community College, in the amount of \$28,470.40, as presented.
