## FOR BOARD ACTION:

**Recommendation:** Staff recommends board approval of the endowed scholarships and chairs listed below:

- 1. Bossier Parish Community College
  - a. AEP/BREMCO Two-Year Endowed Workforce Scholarship in Nursing \$600,000 (\$300,000 private: \$300,000 public)
- 2. SOWELA Technical Community College
  - a. Two-Year Endowed Workforce Scholarship in Industrial Instrumentation Technology \$40,000 total (\$30,000 private: \$10,000 public)
  - b. Two-Year Endowed Workforce Scholarship in Welding \$40,000 total (\$30,000 private: \$10,000 public)
  - c. Greater Lake Charles Rotary Club Endowed First Generation Scholarship

\$50,000 total (\$30,000 private: \$20,000 public)

**Background:** The Board of Regents Support Fund is funded through the interest earnings from a Trust Fund dedicated in the Louisiana State Constitution. Each year, funds are allocated to endow program chairs, professorships and scholarships. Colleges are responsible for contributing private funds that matched with public funds according to Board of Regents policies. One of the policy requirements is approval of the endowments by the respective management board prior to submission to the Board of Regents.

**History of Prior Actions:** There is a history of approving the establishment of endowments at LCTCS colleges to comply with Board of Regents match requirements.

**Fiscal Impact:** These four endowments are the result of \$360,000 private donations. If the matches are approved by the Board of Regents, these endowments will secure an additional \$340,000 in state funding, for a total increase in net assets of \$700,000.

**Benefits to System:** This will help our colleges takes steps towards reaching the \$50 million asset goal laid out by Our Louisiana 2020.

Bossier Parish Community College has received a generous gift from AEP Southwestern Electric Power Company in the amount of \$300,000. Consequently, BPCC seeks approval from the Board of Supervisors to establish the AEP/BREMCO Two-Year Endowed Workforce Scholarship in Nursing.
