A. CALL TO ORDER

Chair Grissette called the February 8, 2017, LCTCS Board of Supervisors monthly meeting to order at 10:10 a.m.

B. PLEDGE OF ALLEGIANCE

Supervisor Charles Strong led the assembly in reciting the Pledge of Allegiance.

Out of respect for the guests in attendance and by privilege of the Chair, item F. Special Presentation was taken up immediately following the Pledge of Allegiance.

F. SPECIAL PRESENTATION: SIGNING CEREMONIES:

The Louisiana National Guard *Troops to College Agreement*The Army Reserve Louisiana Recruiting Battalion *Student Soldier Agreement*The Louisiana National Guard *Youth Challenge Program Memorandum of Understanding*

Dr. Sullivan thanked the armed service organizations for their service and sacrifice for the USA and each person in the room. LCTCS has a long standing history of partnering with the military. LCTCS was the first system to have all of its colleges noted as Veteran friendly campuses in the State of Louisiana. These agreements will provide more opportunity for military personnel to earn degrees from LCTCS colleges.

Dr. Paul Carlsen reiterated the long standing tradition at LCTCS to serve the military and provide an easy transition for veterans. The agreements today will provide a better opportunity for veterans to receive training and education from LCTCS colleges.

Dr. Carlsen invited US Army Reserve Lieutenant Colonel Eric M. Saulsbury, the Baton Rouge Battalion Commander, to speak about the partnership/agreement. Lt. Col. Saulsbury noted that the agreement will encourage students to graduate and assist in job placement for military graduates. He thanked Dr. Sullivan, Dr. Carlsen, and Dr. René Cintron for their help and guidance to make this agreement a reality.

All parties signed the agreement and a photo was taken.

Dr. Carlsen invited Col. Michael Borrel, Director of Education Programs, Louisiana National Guard, to address the Board. Col. Borrel shared a video about the Youth Challenge Program (YCP) with the Board. He noted that the YCP is a program that reclaims the lives of 16-18 year old at risk youth and make them productive citizens. It is a five month residential program that provides education and training to the students. There is a program that allows up to thirty students from each class to attend an LCTCS school. Upon completion of the YCP, the students are encouraged to get a job, continue their education, or enter the military. There is an 80% success rate. The program with LCTCS that began about a year ago has allowed 120 students from YCP to obtain training at the college level.

Dr. Sullivan asked all of the students in attendance to introduce themselves to the Board. Each student stated their name, hometown, and course enrolled in. Dr. Sullivan advised each to finish their programs.

All parties signed the agreement and a photo was taken.

Joey Strickland, Secretary of the Louisiana Department of Veteran Affairs, spoke about the importance for providing education opportunities for veterans. He thanked all parties involved in the agreements that will benefit veterans in Louisiana. He spoke about the services that the Office of Veteran Affairs is able to offer to veterans in Louisiana. He presented Dr. Sullivan,

on behalf of LCTCS, two books - *Korea Reborn: A Grateful Nation* and 25th Anniversary: The Liberation of Kuwait. These books are given to veterans in Louisiana.

Dr. Sullivan introduced Louisiana Delta Community College SGA President, currently serving on the Louisiana Board of Regents and a former member of this Board, Mr. Benson Kinney.

Mr. Kinney gave a presentation about creating safe zones at college campuses for those who are recovering from substance and alcohol abuse. Mr. Kinny asked for the support of the LCTCS Board in his effort to create this program. The Board valued his idea and had many questions related to the program and its potential for success within the LCTCS. Dr. Sullivan agreed to a further discussion to find a college within the system to pilot this program and to discuss at a future meeting.

1. Chair of the Board Report

Chair Grissette provided the following report:

- 2. President's Report

Dr. Sullivan provided the following report:

- ❖ Invited South Central Louisiana Technical College Director Earl Meador to discuss the apprenticeship program. SCL received a national contract from the Department of Labor to promote apprenticeships in the maritime and transportation sector nationwide. The contract is based on the format that there would be five sectors of excellence throughout the country, based in south Louisiana. The first sector of excellence meeting was held recently. More than twenty businesses met to discuss apprenticeships. Representatives from the River Region (petrochemical and refining industry) as well as Coastal Maritime (inland brown water and off shore operators) attended the meeting and began discussion on creating apprenticeships in their industry. The contract will provide for funds over the next five years to entice businesses to develop long standing apprenticeship programs. This meeting is the first step to creating opportunities for unemployed individuals to enter the workforce via an apprenticeship program. Director Meador will continue to discuss this program with the Board in the future.
- Provided the following campus updates
 - Bossier Parish Community College (BPCC) was nominated and is a finalist for the national Bellwether Award for its Open Campus.
 - South Louisiana Community College (SLCC) recently opened the new healthcare facility and honored founding LCTCS Board Member, Brett Mellington.
- ❖ Budget update: As a system, over a nine year time period, there have been sixteen budget reductions totaling an \$82 million reduction in the state general fund. In some cases, those funds have been replaced with tuition, but not fully. Currently, the state is facing a fiscal year deficit of \$300 million for FY 16/17 and projected to be another deficit of \$400 million for FY17/18. Additionally, in June of 2018, \$1.5 billion in sales taxes will roll off as a revenue source. The fiscal circumstance of the LCTCS Colleges, and the State of Louisiana, is bleak. Dr. Sullivan thanked Chairman Hardy for his direction and the support of the Board to begin the process of reviewing efficiencies within the system

and determine the best path forward for the system. The LCTCS will continue to focus on being great every day even with the budget challenges that it faces.

On motion by Supervisor Potts, seconded by Supervisor St. Blanc, the Board voted to authorize the President to execute a right of way agreement between the LCTCS, on behalf of Northshore Technical Community College (NTCC), and CLECO Power, L.L.C. for the connection of electrical service and the continued maintenance of the utility distribution equipment to be installed to service the new Lacombe campus that is currently under construction. The legal description and technical drawing illustrating the area to be transferred will be maintained in the office of the Chief Operations Officer. The motion carried.

6. Cooperative Endeavor Agreement between Northshore Technical Community College and St. Tammany Parish Government

On motion by Supervisor St. Blanc, seconded by Supervisor McConduit, the Board voted to authorize the President and the Chancellor of Northshore Technical Community College to execute a Cooperative Endeavor Agreement, on behalf of the LCTCS, with the LCTCS Foundation and St. Tammany Parish Government to enter into a servitude agreement with the St. Tammany Parish Government to facilitate proper drainage in St. Tammany Parish, and utilize funds reimbursed by the St. Tammany Parish Government for the servitude to construct an outdoor classroom. The legal description and technical drawing illustrating the area of the servitude will be maintained in the office of the Chief Operations Officer. The motion carried.
