Recommendation: Staff recommends the Board approve the following revisions to allow the program to be offered up to 100% through distance education technology.

Program Revisions to be Delivered 100% through Distance Education Technology

- 1. Associate of Applied Science (AAS) in Criminal Justice (CIP 43.0104) - 4 STARS
2. Associate of Applied Science (AAS) in Business Administration (CIP 52.0101) - 5 STARS

Background: The AAS in Criminal Justice has agreements with Nicholls State University and Lafourche Parish Sheriff's Office. The expansion to an online environment supports other pending agreements with various regional Law Enforcement Agencies requesting online classes. The AAS in Business Administration will also have similar partnerships. Introducing these programs in an online modality will provide access and flexibility to non-traditional and non-local students increasing enrollment and completion.

Fiscal Impact: Faculty and resources are already allocated under the existing curriculum. Additional faculty members (one for each program) will be necessary as the programs grow. Adjunct faculty contract will be issued as enrollment increases.

History of Prior Actions: There is a history of offering programs via distance education technology to meet student and workforce needs.

Benefits to the System: These revisions will allow FTCC to better meet student and workforce needs.
