A duly called meeting of the Board of Directors of LCTCS Facilities Corporation was conducted by conference call on Thursday, August 4, 2016, commencing at 4:03 p.m. Directors of the Corporation present included: Chair Stevie Smith, Secretary/Treasurer Lambert Boissiere, Director Gene Thibodeaux, and Director Billy Montgomery, representing a quorum of the Board. Other participants included: Sara Kleinpeter, Gretchen Lindquist, Ed Jenkins, Joseph Marin, and Anthony Brown.

## ITEM I: Welcome and Approval of June 23, 2016 Minutes

Director Smith welcomed the group and asked for approval of the June 23, 2016 minutes.

BOARD ACTION: Director Montgomery moved to accept and approve the minutes with a second by Director Boissiere and the motion carried.

ITEM II: ACT 360 Northwest Louisiana Technical College, Workforce Development Building, Minden Request for Furniture, Fixtures & Equipment Purchase

Ed Jenkins, CSRS, said CSRS reviewed the following purchase requests by Northwest Louisiana Technical College and recommends approval. LCTCS followed State and Facilities Corporation guidelines, by receiving three (3) competitive bids for equipment that is not on State Contract.

1. Five (5) Advanced Welders with Multi-Purpose Education Ready Package, Five (5) TIG Welders, One (1) Welding Performance Management System Simulator, and Five (5) Welding Booths.

ITEM III: ACT 360 South Central Louisiana Technical College Center for the Advancement of Technology & Process Technology Building, Reserve Campus Change Order #3

Ed Jenkins, CSRS, and his project team reviewed and analyzed the change order requests from B.E.T. Construction, for a total of 101,892.92 and zero (0) days added to the contract. Substantial completion will remain December 8, 2016.

ITEM IV: SOWELA Technical Community College CDBG Project Regional Training Center, Lake Charles Change Order #11

Ed Jenkins, CSRS, and his project team reviewed and analyzed the change order requests from Alfred Palma, LLC, for a total of \$71,745.71 and thirty-five (35) days added to the contract. Substantial completion will change from June 4, 2016 to July 9, 2016.

BOARD ACTION: Director Boissiere moved that the Board approve Change Order #11 for the SOWELA Technical Community College Regional Training Center, revising the contract with Alfred Palma, LLC by \$71,745.71 and thirty-five (35) days added to the Contract. The date of Substantial Completion will be revised from June 4, 2016 to July 9, 2016. Director Montgomery seconded the motion and the motion carried.
