Each have been bid but the bids have all been extremely over budget because of the cost of building materials and labor. When asking the low bidders to reduce the project to the budget needs, the projects no longer need the needs of the academic programs they are being built to support. Each college, with the help of LCTCS, are actively pursuing additional funding sources that will allow the project(s) to move forward.
